- 3. English Test Score Certificates (issued since July 10, 2010)
  - The minimum score is as follows: TOEIC 700, TOEFL 80(IBT)/213(CBT)/550(PBT), TEPS 557, TEPS Speaking 50, TOEIC Speaking 120, OPIc IM1
- \*\* Those who have or will have doctorate degrees by August 31, 2012 are exempt from this requirement.
- 4. English Presentation: 30 minutes for each interviewee including a 10-minute presentation & a 20-minute Q/A session
  - This requirement is applicable only to those who have passed the 1st phase screening. Please bring your file and 6 hard copies to your interview.
